THIS RIDER IS HEREBY ATTACHED AND MADE PART OF THE CONTRACT BETWEEN THE ORIGINAL COASTERS, INC. F/S/O THE COASTERS Therein referred to as "ARTIST" and \_\_\_\_\_  
\_\_\_\_\_ hereinafter referred to as "PURCHASER"

1. **PURCHASER** agrees to supply at his sole cost and expense up to five back-up musicians. Keyboard, Drum, Bass guitar, Tenor Sax, Trumpet. **Music Director** is lead guitar. **All Musicians must be able to read music.** PDF's of all our charts and a drop box link can be sent to the bandleader for the purpose of helping the musicians prepare for the show. This is **highly recommended** and will be coordinated by our **MUSIC DIRECTOR**, Ray Sabatello. E-mail: rsabatello@aol.com cell (631)871-4311
2. **PURCHASER** agrees to provide **ARTISTS** with high quality sound system with four removable hand mikes (58 Shure) preferably wireless or with a cord of at least 30 feet long. Four(4) on stage monitor, additional Guitar Amp for musical director (Fender Twin, Deluxe reverb or Blues Jr. or similar amp) music stand with light for musical director.
3. **PURCHASER** agrees to furnish **ARTISTS** with (5) rooms accommodations at first class hotel or equivalent within a reasonable distance to venue if not on site.  
(4 singers and 1 Musical Director.)
4. **One additional room** if **Manager**, Veta Gardner is accompanying group at no cost to **ARTISTS**.
5. **PURCHASER** agrees to furnish (5) airfares when required. (6) if **Manager** travels with group.
6. **PURCHASER** agrees to provide all ground transportation including airport pick up and return.
7. **PURCHASER** agrees to provide clean and well lit dressing rooms for **ARTISTS** and accompanying band members with towels and bottled spring water.
8. **PURCHASER** must arrange to have adequate security personnel to insure privacy and safety of Artists and other personnel accompanying **ARTISTS** before and after performance.
9. **ARTISTS** to receive 100% star billing if **ARTISTS** is headliner in all advertising, including but not limited to all media, all electronic media, and all marquees, unless otherwise negotiated
10. **PURCHASER** will not permit or allow any audio or visual recording without Management permission.
11. **PURCHASER** must not advertise **ARTISTS** appearance until contract is signed both parties
12. **PURCHASER** agrees to provide at least one hot meal for Artists and accompanying band members on night of

performance also deli tray and cold beverage at rehearsal. Spring water room temperature on stage.

**ARTISTS** shall have the sole and exclusive right, but not obligated to sell merchandise items.

**PURCHASER** agrees to pay full contract price if show is canceled due to poor sales of tickets or any reason other than the **ACT OF GOD** i.e. poor weather conditions. **ARTISTS** shall have the sole right to determine in good faith whether weather conditions shall render the performance (s) impossible, hazardous or unsafe.

**All deposits are non refundable unless artist fails to show-up.**

**ARTISTS** & Musical Director request (5) comp tickets if not private party.

**ADENDUM TO CONTRACT**

**PURCHASER** agrees that in the event **ARTISTS** is required to do a Movie or Broadway show that they will be released from contract provided a reasonable time is given for **PURCHASER** to get a replacement.
